## AVAILABILITY

Available in all areas served from the interconnected system of the Company. Available as a Rate Rider to residential Customers taking service under Rate FD, FD-D, RTA, or Rate RTA-Energy Only.

## APPLICABILITY

Applicable for service to single residences and individual family apartments as an optional Rate Rider to residential Customers taking service under Rate FD, FD-D, RTA, or Rate RTA-Energy Only and who own or lease a plug-in electric vehicle (PEV). Qualifying PEVs include battery electric and plug-in hybrid electric vehicles with no fewer than four wheels in contact with the ground when operating and suitable for operation on all public streets, roads and highway systems. Transportation equipment such as electric motorcycles, golf carts, all-terrain and off-road vehicles do not qualify under this Rate Rider.

Prior to the commencement of electric service under this Rate Rider, the Customer must submit Company approved documentation verifying possession of a qualifying PEV at the primary residence served under this Rate Rider.

## CHARACTER OF SERVICE

Single phase service at approximately 120 or 120/240 volts will be provided hereunder. Three phase service or other service upgrade requests will be provided in accordance with Alabama Power Company service regulations.

## MONTHLY RATE DISCOUNT

PEV CHARGING PERIOD  
9:00 p.m. – 5:00 a.m. (Central Time)  
Weekdays, Weekends and Holidays

The Customer's metered kWhs during the PEV CHARGING PERIOD billed in accordance with the applicable rate schedule will be discounted by:

1.7155¢ per kWh

## **DETERMINATION OF MONTHLY RATE DISCOUNT**

The monthly energy rate discount shall be applied to all kilowatt-hour (kWh) usage metered during the PEV CHARGING PERIOD at the qualifying principal residence, and excluding charges under Rate ECR, adjustments under Rate T, and the Utility Gross Receipts Tax.

All provisions of Rate FD, FD-D, RTA, or Rate RTA-Energy Only not specifically mentioned in this rider are incorporated by reference and remain in effect.

In any month in which the Customer is charged the Minimum Billing under the applicable rate for electric service, the discount shall be waived and shall not apply.

## **TERM OF CONTRACT**

Service under this Rate Rider shall be for a period of one (1) year and shall expire unless renewed by Customer. A renewal notice will be distributed prior to the end of each annual term. A Customer can renew service by completing Company approved documentation verifying continuing eligibility for service under this Rate Rider. A Customer may cancel service under this Rate Rider during an annual term without penalty in the event Customer no longer qualifies for service.

## **GENERAL**

Service under this Rate Rider is subject to rules and regulations approved or prescribed by the Alabama Public Service Commission.
