1. Upfront Payments for Non-Standard Service

A. Company Owned Luminaires

If a Customer wants the Company to install decorative luminaires, but only wants to be billed the monthly rate for the standard comparable wattage cobra head luminaire, an upfront cost can be calculated to allow the Customer to pay the additional cost above the cobra head luminaire rate. This cost will include the price differential above the cobra head luminaire plus the present value of future ownership costs to recover future maintenance costs, property and other taxes (as applicable), administrative and general costs, replacement costs, plus an applicable time value of money allowance (CIAC tax).

B. Company Owned Poles

i. If a Customer wants the Company to install decorative poles, but only wants to be billed the monthly rate for the standard comparable height wooden pole, an upfront cost can be calculated to allow the Customer to pay the additional cost above the wooden pole rate. This cost will include the price differential above the wooden pole plus the present value of future replacement costs to recover future ownership costs, property and other taxes (as applicable), administrative and general costs, replacement costs, plus an applicable time value of money allowance (CIAC tax).

ii. If a Customer wants to make a one-time payment and not be billed a monthly pole rate, an upfront cost can be calculated. The one-time payment will include the present value of future ownership costs to recover future maintenance costs, property and other taxes (as applicable), administrative and general costs, replacement costs, plus an applicable time value of money allowance (CIAC tax).

C. Additional Facilities Charges

If a Customer wants to make a one-time payment toward any applicable additional facilities charges, an upfront cost can be calculated. The one-time payment will include the present value of future ownership costs to recover future maintenance costs, property and other taxes (as applicable), administrative and general costs, replacement costs, plus an applicable time value of money allowance (CIAC tax). Any remaining additional facilities charges will be billed monthly according to the provisions of the applicable rate.

2. Converting Company Owned Luminaires

In cases where the Customer desires the Company to convert a luminaire which has been installed less than five (5) years, the Customer will be required to pay the Company \$90.00 per luminaire to cover the cost of removal and disposal of the luminaire. If the luminaire has been installed five (5) years or more, the Company will convert such luminaire at no cost to the Customer.

3. Replacing Discontinued Company Owned Luminaires

Because of the inefficiency, higher operating cost and federal regulations, several luminaires have been discontinued by the Company and are no longer available on new or replacement Company owned installations. If a discontinued luminaire fails, the Company will replace it, at no cost to the Customer, with a comparable luminaire chosen by the Customer. The Customer will be billed monthly at the rate applicable to the replacement luminaire.

4. Maintenance of Street Lighting Equipment – Rate SLM Only

Routine maintenance of both Company-owned and Customer-owned street lighting equipment shall include cleaning of the fixture optic assembly, reflector and glassware, and group replacement of all lamps on a five year cycle. Spot lamp replacement and photoelectric control maintenance will be performed as required by lamp failure or control malfunction. All other required maintenance of Company-owned luminaires will be performed on an as needed basis. Where access requires traffic control measures deemed to be beyond the Company's standard procedures (e.g., Freeways), the Company will provide lamps and photoelectric controls to the Customer and the performance of the necessary replacements will be the responsibility of the Customer.
